BEACH CLUB RULES AND REGULATIONS

Operating Hours: 8:00AM to 6:00PM (except Monday)

Swimming Pool Usage: 8:00AM to 6:00PM

Beach Swimming is allowed until 6:00PM only.

GENERAL RULES

- ❖ Wristbands must be worn at all times while inside the resort premises.
- ❖ Children below twelve (12) years old should be accompanied by an adult at all times. Likewise, a person with disability (PWD) must be accompanied by the parent or guardian at all times.
- ❖ Everyone is expected to observe to wear proper swimming attire. Appropriate swimming attire shall include swimming trunks, bathing suits, and board shorts. T-shirts, walking shorts, athletic shorts, "maong" shorts, cotton fabric shorts/attire and basketball shorts are not allowed.
- ❖ Infants are required to wear plastic pants or swim diapers in the pools.
- ❖ Swimming while intoxicated is strictly prohibited.
- ❖ Spitting, spouting water, blowing of the nose, and/or discharging of bodily wastes in the beach and resort premises are strictly prohibited.
- ❖ Swim only on the prescribed swimming zones as marked by buoys. No swimming beyond the buoys. The management assumes no responsibility for any untoward incidents beyond the prescribed swimming zones.
- ❖ **To preserve the exclusive appeal of the beach club, bringing in of foods contained ("kaldero, kawali, kaserola", sack, rusty rice cookers, etc.) is not allowed.**
- ❖ **Drinking waters contained in big 5-gallon water containers with faucet is not allowed.** Only clear water containers or waters contained in coolers and jugs are allowed.
- ❖ **Corkage fee shall apply on all alcoholic beverages that are brought inside of the resort.** Corkage fee will be based on the prevailing Suggested Retail Price (SRP) or retail price of the item/s.
- ❖ The members/guests may opt to order their food and beverages at the various concessionaires in Calatagan South Beach without any additional corkage fee.
- ❖ Use of cabanas, picnic tables, and griller are on a first-come-first-serve basis with applicable charges. No charcoal is available or sold at the resort.
- ❖ Materials that may pose a danger to other pool users and are of hazardous by nature such as metals, hard plastics, sharp objects, glass that may break are not allowed in or near the pool.
- ❖ Running, pushing, and playing rough games is strictly prohibited while inside of the resort. Management will not be held liable for any untoward incidents caused by these activities.
- ❖ Persons having an infectious or communicable disease are prohibited from loitering in the pool and the beach area.
- ❖ Vaccinated pets are allowed inside the resort premises provided that they shall not exceed one (1) foot in height and shall be leashed at all times. It is the members or guests' responsibility to clean/scoop and dispose properly any waste from their pet/s.
- ❖ Collection of sea creatures such as starfish, small fish is strictly prohibited by the Management. Avoid possible contact with sea urchins and corals as they can cause serious injuries.
- ❖ No littering. Dispose trash into the bins located within the resort premises.
- ❖ Soaps or similar materials are not allowed to be used in the beach area and swimming pool areas.
- ❖ Noise should be maintained at minimum volume level within the twenty (20) meters radius of source to avoid any inconvenience to other members/guests. For overnight campers, noise should be toned down at 10:00PM onwards.
- ❖ **Pitching of tents is only allowed from 5:00PM onwards and should be folded by 8:00AM the following day. No tents are allowed to be pitched during the day.**
- ❖ Any physical damages on the Beach Club facilities or amenities caused by the guests shall be chargeable to the guest.
- ❖ The management reserves the right to evict members and/or guest/s who shall violate these rules for the safety of others.
- ❖ The management reserves the right to alter the rules and regulations without prior notice as deemed necessary.

WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT (PLEASE READ CAREFULLY)

In consideration of the permission to use the recreational facilities and amenities, premises or equipment, if any, of **Playa Calatagan Beach Club/ Hilltop Clubhouse**, which include, but are not limited to, the Swimming Pool, Clubhouse, I knowingly agree that:

1. Use of facilities and amenities, premises or equipment, if any, is at the discretion and sole risk of the USER and I understand that I am fully responsible for myself, my family members, guests, tenants and invitees;
2. Use of facilities and amenities, premises or equipment, if any, is unsupervised and that there is **NO LIFEGUARD ON DUTY** for the Swimming Pool;
3. All activities carry inherent risks and accident, injury or death may occur as a result regardless of the care taken;
4. I, my family members, guests, tenants and invitees will follow the guidelines, rules and regulations of Playa Calatagan Village Homeowners Association, Inc. and Primefrontier Property Management, Inc., as may be amended from time to time;
5. Playa Calatagan Village Homeowners Association, Inc. and Primefrontier Property Management, Inc. have the right to deny access to and/or to remove myself, my family members, guests, tenants and invitees from the recreational facilities and amenities, or premises for misconduct, violation of guidelines, rules and regulations, or for any other reason that they, in their sole discretion, deem appropriate;
6. Playa Calatagan Village Homeowners Association, Inc. and/or Primefrontier Property Management, Inc., their directors, officers, employees, and agents, is released and discharged from any liability and/or any and all claims, including negligence resulting in personal injury, accident or illness (including death), and property loss arising from, but not limited to, participation in activities/events, and use of facilities and amenities, premises or equipment, if any;
7. I, my family members, guests, tenants and invitees will defend, indemnify, and hold harmless Playa Calatagan Village Homeowners Association, Inc. and Primefrontier Property Management, Inc., including their agents, and employees, from and against any and all claims, demands, causes of action, costs, expenses, damages and liabilities, including attorney's fees, brought as a result or associated with the use of facilities and amenities, premises or equipment, if any, and I, my family members, guests, tenants and invitees will reimburse them for any such expenses incurred;
8. I have been fully authorized by my family members, guests, tenants and invitees to represent them and to sign this Waiver of Liability, Assumption of Risk and Indemnity Agreement in their behalf, and it is my responsibility to inform them that my signature below is intended to be a complete and unconditional release of liability of Playa Calatagan Village Homeowners Association, Inc. and Primefrontier Property Management, Inc.;
